<u>C. Budget:</u> Jodi K. went over the budget as of March 31<sup>st</sup>, and showed the corrected line for Campbell's Soup Labels. She said the spirit wear line would be updated as well.

D. Jodi K. said she received an email from Mr. Gendron and Mrs. Zigler saying Randall students really enjoyed the recent assembly.
